

## HEALTH **System**

The health system in Australia is of a very good quality. All employees are enrolled in the Medicare Plan, allowing for the reimbursement of a large portion of the cost of care. In order to bene fit from it, one must be a permanent resident and meet specific conditions, in particular: To be a permanent resident for more than 2 years / To have Australian nationality / To come from one of the countries having a bilateral agreement with the Australia: New Zealand, United Kingdom, Italy, Sweden, Finland, Netherlands, Malta, Ireland.

Anyone who benefits from Medicare will be eligible for the Medicare Card. This system does not cover dental expenses, except for pensioners and recipients of benefits paid by the Ministry of Social Security. As in France, consultation.

#### Pour les étudiants

Foreign students also benefit from the student social security Overseas Student Health Cover (OSHC). The insurance is dedicated only to people with a student visa.

Registration entitles you to a social security number and an insurance card that is the Australian vital card. The OSHC card must be presented at each consultation.

# **VACCINES**

#### Japanese encephalitis

The vaccine is recommended for long-stay people in Australia (more than a month) if you travel during the rainy season, vaccination is even more essential. The vaccine is, moreover,

### Yellow fever

Australia is a country where the risk of disease is very low. It is, moreover, required to be vaccinated for people from an infected country.

#### **Typhoid**

Anyone visiting Australia on a long stay (longer than one month) should be vaccinated against the disease, especially those traveling to areas where hygiene conditions do not respond. to the required standards.

#### **Hepatitis A**

Vaccination against liver disease is essential for people with the disease. Travelers over the age of 50 are required to perform a prior serological check to determine if vaccination is necessary.

### Leptospirosis

Transmitted by contact with fresh water, the disease can lead to major complications (renal insufficiency, among others). Leptospirosis is a bacterial disease that mainly affects people engaged in nautical

# THE CARE "TAKEN-IN-CHARGE" BY **OSHC** :

- Consultations with the general practitioner
- Hospitalization in a public and common room environment: if you are in a private institution, you will have to pay fees.
   Ask beforehand. If you have subscribed in parallel to an international health insurance, you will be refunded, otherwise, no..
- Transport by ambulance
- Some of your medicines (with a ceiling of 150 Australian Dollars per year and per person, just 100 €)

## THE CARE NOT "TAKEN-IN-CHARGE" BY **OSHC**:

- Care related to pregnancy
- Medicines resulting from a treatment started in France
- Treatments following an accident: dental expenses, optical expenses, physiotherapy sessions.
